## Warehouse rental

Warehouse rental is charged for cargo that is stored in warehouses or containers, after the applicable 5 free days that are included in a transport arrangement with Royal Arctic Line, both before and after the transport in question. Warehouse rental that is not associated with any transport is billed without free days. The warehouse rental is calculated per day per cubic metre, with a minimum fee of minimum DKK 50 per rental period or part thereof.

## Terminal space rental

Terminal space rental is charged for containers, including customers' own containers (Shipper's Own Containers) and general cargo that cannot be stored in warehouses. This is usually oversized cargo or heavy cargo. When the free period of 5 days from arrival to final destination is exceeded. The terminal space rental for general cargo is calculated per day per cubic metre, with a minimum fee of DKK 50 per rental period or part thereof.

## Container rental

The rental of mini containers, 20-foot and 40-foot containers is included in freight between Denmark and Greenland, and internally within Greenland. This includes the renter's use of the container for a maximum of 5 calendar days (including weekends and public holidays) prior to the last delivery date, and 5 calendar days from the container being declared ready for dispatch.

## Customs clearance of cargo

When you send a product with a value exceeding DKK 80 to a country within the EU, you must pay VAT, customs duty and an import fee (customs clearance fee) for the product. Royal Arctic Line can offer customs clearance of shipments from Greenland for a fee.

In addition to customs duty, VAT must be paid if the value of the shipment is DKK 80 or more.

VAT is 25% and is calculated on the basis of the value of the goods, postage and customs duty.

The derogations only apply if the recipient in the EU is a private recipient. If it is a company, there are no derogations.

## OIL AND CURRENCY SURCHARGES

Oil and currency surcharges (BAF/CAF) are charged separately to adjust for additional costs due to fluctuations in oil prices and/or exchange rates (USD).

The oil and currency surcharge is calculated as a percentage of the sum of:

- handling at the port of discharge
- sea freight
- handling at the port of arrival

The oil and currency surcharge is adjusted in the event of significant fluctuations and is updated at [www.ral.gl](http://www.ral.gl).

## INVESTMENT CONTRIBUTION

The investment contribution was adopted in the Danish Finance Act for 2011, and represents, in connection with the investment in new settlement vessels, an alternative to raising the subsidy amount in the service contract paid by the Government of Greenland for the performance of the task of transporting cargo to the settlements.

The investment contribution was introduced from 1 February 2011 and amounts to 3.1% for all freight shipped by Royal Arctic Line, but also by Atlantic and coastal traffic in Royal Arctic Line.

## BORDER CONTROL

Royal Arctic Line offers to arrange documentation for use in connection with the border control in Aarhus (CVED + health certificate) against payment. In order to be able to issue the necessary documentation, the content of the container(s) in question must be reported to Royal Arctic Line.

## DEAD FREIGHT

Royal Arctic Line can charge a so-called "dead freight" fee for loss of freight revenue and subsequent consequences, in accordance with the provisions in the Danish Merchant Shipping Act, if a confirmed booking is cancelled or if the volume or weight delivered for shipment is significantly less than booked.

If cancellation takes place within eight days of the ship's departure, the shipper must pay an amendment fee. If cancellation takes place later than eight days before the ship's departure, the shipper must pay an amendment fee plus 50% of the lost freight income, if the amendment of the booking is more than 10 cubic metres.

## AMENDMENT OR CANCELLATION OF BOOKING

If a booking is cancelled or amended to a smaller number of cubic metres or containers than originally booked, Royal Arctic Line may charge costs associated with the cancellation or amendment.

Cancellation fee/amendment fee. .... DKK 300

If cancellation takes place of cargo that has been delivered, a cancellation fee must be paid, as well as payment for the costs of retrieval and delivery. If cancellation takes place of cargo that has not been delivered within eight days of the ship's departure, the shipper must pay the amendment fee.

If cancellation takes place later than eight days before the ship's departure, the shipper must pay an amendment fee plus 50% of the lost freight income, if the amendment of the booking is more than 10 cubic metres.

If pallets are added and this causes the cargo's cargo code, volume or weight to be amended, the shipper must pay an amendment fee. If a container number is moved from one booking to another, the shipper must pay an amendment fee.

## INSURANCE

Transport insurance is calculated at a premium of 0.765% of the value of the total shipment.
